- 3 The Deeds and Documents of Title having been lost the land tinted yellow on the title plan is subject to such restrictive covenants as may have been imposed thereon before 26 November 1980 and are still subsisting and capable of being enforced.
- 4 The land tinted yellow on the title plan is subject to the following rights granted by a Deed dated 11 May 1961 made between (1) Irene May Dewsbury Jackson (Grantor) and (2) Patrick Joseph Regan and Mary Regan (Grantees):-

"THE Grantor as Beneficial Owner hereby grants to the Grantees and their successors in title owner or occupier for the time being of the Grand Picture Theatre Old Hill aforesaid and their tenants and servants and all persons authorised by them a right of way over and along the yard shown yellow on the plan attached hereto such right of way to be used as an emergency exit from the doors at the rear of the Grand Picture Theatre to Priest Street aforesaid".
